Terms and Conditions

1. Moonshadow Yacht Charter Ltd gives notice that all arrangements made by us are on the condition that we shall not be liable for any death, injury or damage, loss, delay or irregularity which may be caused by persons or conditions out with our control. We accept no responsibility for any losses or additional expense due to delays in changes in air, road, rail, sea or other services, strikes, war, weather or other causes.
 2. Without prejudice or liability on the part of Moonshadow Yacht Charter Ltd, charterers are strongly advised to take out personal insurance to cover, inter alia, personal accident/injury, travel costs arising from changes in the yacht's passage plan, loss or damage of personal property, loss of booking fees in the event of client cancellation.
 3. The accommodation is not booked until the completed Booking Form and a deposit of 25% of the fee has been received. Provisional bookings by phone or e-mail will be held for 10 days pending receipt of the Booking Form and deposit. Every person making a booking on behalf of an individual or group of individuals warrants and confirms that he/she has the authority of that individual and that each such individual agrees to be bound by these Terms & Conditions. All cheques to be made payable to "Moonshadow Yacht Charter Ltd Clients Account". *Payment may also be made by bank transfer; details available on request.* Moonshadow Yacht Charter Ltd reserves the right to alter prices in accordance with any major changes in cost which may occur between the time of the booking and the time of departure.
 4. Charterers signing the Booking Form are declaring that they, and all persons on whose behalf they are booking, are in good health and are fit, mobile and agile. Any illness arising between booking the holiday and actual departure must be declared. The skipper may refuse to carry any individual or luggage on any charter for any cause relating to the safety of the vessel or any property or other persons on board. In such circumstances the individual shall not be entitled to any compensation or payment whatsoever except we shall refund to the individual any fee paid to us in respect of that charter unless a serious health concern has not been declared beforehand.
 5. To comply with Statutory Instrument 1992 No. 3288 "The Package Travel, Package Holidays and Package Tour Regulations 1992", Moonshadow Yacht Charter Ltd holds all booking fees in a Clients Account.
 6. If, due to circumstances beyond our control, we cannot provide the charter booked or a suitable alternative, we will refund all money paid, in full, and the charterer shall have no further claim against us. Scheduled charters may also be cancelled up to four weeks in advance of the departure date if insufficient bookings have been made.
 7. The charterer, whether an individual, or booking the whole vessel, is responsible for the whole of the fee he/she has undertaken to pay and must pay the balance at least 45 days before the start of the charter period. If for any reason, the Charterer cancels the booking, he/she remains responsible for the whole of the fee. It may be possible for you to transfer your booking to another individual with our agreement. Alternatively, we will make every effort to resell the berth(s) and if successful will refund the deposit and any other money paid minus any administration costs and other related expenses. **Holiday cancellation insurance is highly recommended.**
 8. The vessel carries full Marine Insurance policies for bodily injury or accident to passengers on board. Moonshadow Yacht Charter Ltd is covered for £3,000,000 in respect of any one incident aboard the vessel. The yacht's insurance does not cover you for any injury, damage or loss to you or your property not attributable to our negligence or any defect in the yacht. Furthermore, our insurance does not cover charterers who are away from the vessel or its tender whilst engaged in watersports or other activities, nor does it cover loss of or damage to passengers' gear, property or valuables whilst onboard or in transit. We therefore recommend that you check your own personal/household insurance cover.
 9. No unaccompanied children under the age of 18 can be carried. No children under the age of 12 shall be carried unless part of a whole boat charter and then they are the responsibility of their parents/guardians at all times. No animals shall be carried unless with prior permission.
 10. No drugs, other unlawful goods or pornographic materials are permitted on board the vessel and the passenger(s) shall free and release Moonshadow Yacht Charter Ltd and its employees from any liabilities or responsibility arising out of any breach of this condition. Smoking is not permitted below deck, but maybe permitted on deck providing it does not disturb other guests.
 11. Moonshadow Yacht Charter Ltd's skipper reserves the right to vary the charter in any way he considers necessary due to adverse weather or any other conditions. The skipper shall have ultimate responsibility for the safety of the vessel, its tender and those on board and his decision shall be final.
 12. In the unlikely event that you have a complaint please report it to us as soon as possible so that we may deal with it promptly and to your satisfaction.
 13. In the event of any dispute between the parties arising out of this agreement, it will be referred to the Disputes Committee of The Association of Scottish Yacht Charterers and an arbitrator appointed whose decision will be binding on both parties.
 14. Any legal action or proceedings arising out of or connected with this contract shall be governed by the Laws of Scotland.
 15. In this agreement the singular will include the plural and the male the female.
